# 136<sup>TH</sup> ANNUAL MEETING OF THE CONGREGATION AND CORPORATION OF FOURTH PRESBYTERIAN CHURCH February 12, 2006

The 136<sup>th</sup> Annual Meeting of the Congregation of the Fourth Presbyterian Church was convened by the Moderator, Dr. John M. Buchanan, at 12:15 p.m. on Sunday, February 12, 2006 in the sanctuary of the Fourth Presbyterian Church. Moderator Buchanan opened the meeting with prayer.
